# Range Rules

1. Use Safe Gun Handling Rules at all TIMES.
2. Keep muzzle pointed in a safe direction at all times.
3. Eye and Ear Protection will be worn by EVERYONE at all times when on the RANGE.
4. Load gun only when on or in a shooting station. Maximum of two rounds.
5. Keep action open at all times except when on a station to shoot.
6. NO alcoholic beverages permitted on the RANGE you will be asked to leave if you have been drinking.
7. Minors must be under adult supervision. Pets and small children must be restrained at all times.
8. No shot larger than # 7 ½. Steel # 7 ok.
9. Be aware of your surroundings, watch for falling debris.
10. Please observe proper range etiquette at all times.
11. Obey ALL Range Safety Officer requests or you will be asked to leave. NO ARGUMENTS.

## READ RANGE RULES AND INITIAL \_\_\_\_\_

### VOLUSIA COUNTY SKEET & TRAP CLUB ASSUMPTION OF RISK & RELEASE OF CLAIM

I am aware that attempting to shoot, shooting and being a spectator while others are shooting clay targets with a shotgun are hazardous activities, and that I am voluntarily participating in these activities, with knowledge of the danger involved and hereby accept any and all risks of injury or death. I understand that when clay targets are launched they could possibly, whether broken or not, fall upon me as a shooter or a spectator, potentially causing serious injury or death. I understand that serious hearing loss may result from being in the proximity of a discharging shotgun. I acknowledge that Volusia County Skeet & Trap Club has advised me to wear eyeglasses and ear protection and that same are made available to me. I understand that serious accidents occasionally occur and can cause serious or fatal injuries as a result of being shot or by other means.

Knowing the risks of participating or observing in clay target shooting events, I hereby agree to assume all risks associated therewith, to release and hold harmless the County of Volusia, County Council, and all employees, or Volusia County Skeet & Trap Club, their agents, employees, volunteers and affiliated organizations who, through negligence or carelessness might be otherwise liable to me, or to heirs or assigns for damages while on the shooting grounds while competing, observing, officiating, or being permitted by the Volusia County Skeet & Trap Club to participate in clay target shooting and all related functions. I hereby agree that I, my heirs and assigns will not make a claim of any kind against the County of Volusia, County Council, all employees, or Volusia County Skeet & Trap Club, their Officers or Shooters and/or any of their affiliated organizations, owners, employees, agents or volunteers for personal injury, death or property damage resulting from negligent or other acts howsoever caused by any owner, employee, guest, invitee, licensee, member, trespasser or agent.

I have carefully read this release, Range Rules and fully understand its contents. I am aware that this is a release of liability and that by signing this release, I am giving up valuable legal rights in exchange for the privilege of participating in clay target shooting and other related activities on the premises. I further agree that this release applies to my minor children participating in shooting related events.
